We only collect data necessary to process your orders, provide customer service, and comply with legal obligations.

4. How We Use Your Information

We use your data to:

- Process and fulfil your orders.
- Manage customer accounts and communication.
- Respond to enquiries or service requests.
- Comply with tax and accounting requirements.
- Improve our website and services.

We do **not** sell, rent, or trade your personal information.

5. Legal Basis for Processing

We process your personal data based on:

- Contract to fulfil your purchase or service agreement.
- Legal obligation to comply with UK laws and accounting standards.
- Legitimate interest to manage our business and communicate with customers.
- Consent for marketing emails (if you opt in).

6. Sharing Your Data

We only share data where necessary, such as with:

- Payment processors and banks.
- Delivery and logistics providers.
- IT, web hosting, and security service providers.
 All partners are GDPR-compliant and only use data for agreed purposes.

7. Data Retention

We retain order and customer records for up to 7 years to comply with tax and legal requirements. After this period, data is securely deleted or anonymised.

8. Cookies

Our website uses cookies to improve user experience and website performance. You can control or delete cookies through your browser settings.

9. Your Rights

You have the right to:

- Access the personal data we hold about you.
- Request correction or deletion of your data.
- Object to or restrict processing.

- File a complaint with the Information Commissioner's Office (ICO).
